ORDINANCE NO. 2136

AN ORDINANCE AMENDING ORDINANCE NUMBER 35, SCHEDULE VI OF THE ORDINANCES OF THE CITY OF CHESTERFIELD BY ADDING A PROVISION FOR A THREE-WAY STOP SIGN AT THE INTERSECTION OF RIVERDALE DRIVE AND EAGLE WINDS COURT THERETO

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

Section 1. Ordinance Number 35, Section 3, Schedule VI as it relates to Intersection Stops is hereby amended by adding a provision thereto as follows:

Intersection

Traffic on Highway, Road, Street or Alley
Listed Below Shall Stop

Riverdale Drive

Eagle Winds Court

Riverdale Drive

Section 2. In all other respects, Ordinance Number 35 is in full force and effect

Section 3. This ordinance shall be in full force and effect from and after its passage and approval.

Dear Mr. Herring:

We met with the Chesterfield Public Works and Safety Committee on October 29, 2003. They explained that they could not take action on our petition until the streets in Eagle Crest were turned over to the City of Chesterfield. We understand the process for takeover is underway. They also stated that they would support our petition - when the takeover occurred - if 90 percent of the residents wanted the stop signs. (All present homeowners in Eagle Crest have signed the petition.)

Since we last met, the upper level of Eagle Crest Estates is now designated as a separate entity, "The Wings at Eagle Crest". Our primary concern remains the traffic flowing through our subdivision on Riverdale Drive. Three new families - all with children - have located on Riverdale Drive since our last meeting. This heightens our concern.

We request that you take our petition to the City Council at the same time the takeover of our streets is to be approved. As always we appreciate the willingness of your staff and the Public Works and Safety Committee in helping us resolve our traffic safety problem.

Dear Mr. Herring:

Per your instructions, enclosed is a petition for three-way stop signs to be installed in our subdivision, signed by all present homeowners (100%). Also, a letter from our trustees endorsing the petition.

We badly need the stop signs to slow the pace of traffic through our subdivision. We note that Countryside at Chesterfield has three-way stop signs at the streets intersecting Countryside Manner Parkway and this helps greatly in reducing the speed of traffic. Further, we have a speed and "line of sight" problem for some homeowners who have to back onto Riverdale Drive. Those living on Eagle Winds Court have much the same problem when they exit onto Riverdale Drive. Three-way stop signs here will greatly reduce this hazard.

If possible, we request the stop signs be mounted on black, round poles. (I noticed some in use on Highway 40 Outer Road in the Valley.) This would blend with our mailboxes. Also, we do not have a street sign for Eagle Bluff Court.


Thanks in advance for your assistance, and please let me know when our petition goes before the City Council. If needed, some of our homeowners will attend the meeting.


