ORDINANCE NO. 2476

AN ORDINANCE VACATING TWO FIVE (5) FOOT WIDE EASEMENTS ON LOT 29 AND LOT 28 OF "TERRA VISTA – PLAT ONE" (P.B. 354 PG. 545 AND 546) AND "TERRA VISTA – PLAT ONE LOTS 15-18, 25-28, 30-32 AND COMMON GROUND BOUNDARY ADJUSTMENT" (P.B. 356 PG 51-52) RESPECTIVELY, OF ST. LOUIS COUNTY, MISSOURI (LEVINSON BUILDING AND REALTY CORP.).

WHEREAS, a petition for vacation of an 1,115 square foot easement located on Lot 29 and Lot 28 in the Terra Vista Subdivision has been filed by Cole and Associates on behalf of Levinson Building and Realty Corp.; and,

WHEREAS, a review of the petition application materials has determined that all other applicable utilities and/or jurisdictions, excepting Union Electric Co., have released their respective interests in said easement; and,

WHEREAS, a review of the petition application materials has determined that Union Electric Co. has partially released their interest in said easement; and,

WHEREAS, the Department of Planning and Public Works has reviewed the petition and has determined that said petition meets all applicable regulations and determined that the vacation will have no adverse effect on the City of Chesterfield.


NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

Section 1. The City Council of the City of Chesterfield hereby approves the easement vacation located on Lot 28 and Lot 29 of "Terra Vista," as depicted in Exhibits A and B and described in Exhibits C and D, which are attached hereto and made part of here of, and,

Section 2. The Mayor and City Clerk are authorized and directed to evidence the approval of the vacations of these easements by affixing their signatures and the Official Seal of the City of Chesterfield to a Certificate of Approval as required on said documents. The petitioner is required and directed to record this easement vacation with the Saint Louis County Recorder of Deeds Office.


Section 3. This Ordinance shall be in full force and effect from and after its passage and approval.


