- A. **BILL NO. 2506** APPROVES THE ACCEPTANCE BY THE CITY OF CHESTERFIELD OF RHL DRIVE AND CHESTERFIELD COMMONS BOULEVARD AS PUBLIC STREETS **(FIRST AND SECOND READINGS; PUBLIC WORKS/PARKS COMMITTEE)**

BILL NO. 2509** AMENDS THE ZONING ORDINANCE OF THE CITY OF CHESTERFIELD BY CHANGING THE BOUNDARIES OF A “NU” NON-URBAN DISTRICT TO A “PI” PLANNED INDUSTRIAL DISTRICT, FOR A 14.28 ACRE TRACT OF LAND, LOCATED NORTH OF WINGS CORPORATE DRIVE AND EAST OF EATHERTON ROAD (P.Z. 21-2006, PRECISION PLAZA {PRECISION PROPERTIES, LLC}) **(FIRST READING - PLANNING COMMISSION RECOMMENDS APPROVAL; PLANNING AND ZONING COMMITTEE RECOMMENDS APPROVAL, BUT ONLY IF AMENDED AS DETAILED IN THE ENCLOSED “GREEN SHEET”)**
- C. BILL NO. 2510** PROVIDES FOR THE APPROVAL OF A RECORD PLAT FOR CHESTERFIELD COMMONS EAST PLAT 2 A RESUBDIVISION OF ADJUSTED LOT 11, FOR AN APPROXIMATELY 14.165 ACRE TRACT OF LAND ZONED “PC” PLANNED COMMERCIAL DISTRICT AND “C-8” PLANNED COMMERCIAL DISTRICT, LOCATED SOUTH OF CHESTERFIELD AIRPORT ROAD AND EAST OF CHESTERFIELD COMMONS DRIVE. **(FIRST AND SECOND READINGS – PLANNING COMMISSION RECOMMENDS APPROVAL)**
- D. BILL NO. 2511** VACATES THE RIGHT-OF-WAY OF OLD WILD HORSE CREEK ROAD AS DEPICTED ON THE EXHIBIT “A” LOCATED IN U.S. SURVEY 164 AND FRACTIONAL SECTION 15 IN TOWNSHIP 45 NORTH, RANGE 3 EAST, CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI. **(FIRST AND SECOND READINGS – PLANNING COMMISSION RECOMMENDS APPROVAL)**
