- A. **BILL NO. 2469** AUTHORIZES THE CITY COUNCIL OF THE CITY OF CHESTERFIELD TO EXECUTE A CONTRACT ON BEHALF OF THE CITY OF CHESTERFIELD, MISSOURI, WITH ST. LOUIS COUNTY, MISSOURI, FOR PROVISION OF MUNICIPAL ORDINANCE PROSECUTION SERVICES, AND PROVIDING FOR THE EFFECTIVE DATE OF THE ORDINANCE (**SECOND READING – PUBLIC HEALTH AND SAFETY COMMITTEE RECOMMENDS APPROVAL**)

C. BILL NO. 2475 AMENDS THE ZONING ORDINANCE OF THE CITY OF CHESTERFIELD BY CHANGING THE BOUNDARIES OF AN “NU” NON-URBAN DISTRICT TO AN “E 1/2 ACRE” ESTATE DISTRICT FOR 61.0 ACRES OF LAND LOCATED NORTH OF STRECKER ROAD AND EAST OF CHURCH ROAD (P.Z. 39-2005, WESTLAND ACRES (WESTLAND ACRES DEVELOPMENT LLC.) **(SECOND READING – PLANNING COMMISSION RECOMMENDS APPROVAL; PLANNING AND ZONING COMMITTEE RECOMMENDS APPROVAL, AS AMENDED)**

BILL NO. 2476 REPEALS CITY OF CHESTERFIELD ORDINANCE 775 AND REPLACES IT WITH A NEW ORDINANCE PROVIDING FOR FINANCIAL INSTITUTIONS, MEDICAL AND DENTAL OFFICES, RESTAURANTS AND DRIVE-UP FACILITIES IN FOUR SEASONS PLAZA, A “C8” PLANNED COMMERCIAL DISTRICT –ZONED PARCEL, LOCATED ON THE SOUTH SIDE OF OLIVE BOULEVARD, DIRECTLY ACROSS FROM THE INTERSECTION OF STATE HIGHWAY 340 AND RIVER VALLEY DRIVE (P.Z. 8-2006, FOUR SEASONS PLAZA (DR. PHIL HENDRICKS)) (**SECOND READING – PLANNING COMMISSION RECOMMENDS APPROVAL**)

BILL NO. 2481 REPEALS CITY OF CHESTERFIELD ORDINANCE 1556 TO ALLOW FOR ADDITIONAL USES AND APPROVES A LANDMARK AND PRESERVATION AREA PROCEDURE (LPA) FOR A 1.95 ACRE TRACT OF LAND LOCATED AT 16625 CHESTERFIELD AIRPORT ROAD AND 16635 CHESTERFIELD AIRPORT ROAD (P.Z. 18-2006 AND P.Z. 22-2006, BECKMANN PROPERTIES) (**FIRST AND SECOND READINGS- PLANNING COMMISSION RECOMMENDS APPROVAL; PLANNING AND ZONING COMMITTEE RECOMENDS APPROVAL, BUT ONLY IF AMENDED AS DETAILED IN THE ENCLOSED “GREEN SHEET”**)

F. BILL NO. 2482 AMENDS THE ZONING ORDINANCE OF THE CITY OF CHESTERFIELD BY CHANGING THE BOUNDARIES OF A “C8” PLANNED COMMERCIAL DISTRICT TO “PC” PLANNED COMMERCIAL DISTRICT FOR A 1.25 ACRE TRACT OF LAND LOCATED ON THE SOUTH SIDE OF OLIVE ROAD, EAST OF CHESTERFIELD PARKWAY (P.Z. 19-2006, KEYS TO SUCCESS (15464 OLIVE BLVD)) (**FIRST AND SECOND READINGS- PLANNING COMMISSION RECOMMENDS APPROVAL; PLANNING AND ZONING COMMITTEE RECOMMENDS APPROVAL, BUT ONLY IF AMENDED AS DETAILED IN THE ENCLOSED “GREEN SHEET”**)
