- A. **[BILL NO. 2569](#)** RELATES TO THE ESTABLISHMENT OF RULES AND REGULATIONS FOR THE SITING, CONSTRUCTION AND MODIFICATION OF WIRELESS TELECOMMUNICATIONS FACILITIES (**SECOND READING - PLANNING COMMISSION RECOMMENDS APPROVAL; P&Z COMMITTEE RECOMMENDS APPROVAL, AS AMENDED**)

DISTRICT, "R-5" RESIDENTIAL 6,000 SQ FT. DISTRICT, AND "FPR-5" FLOOD PLAIN RESIDENTIAL DISTRICT WITHIN A "PEU" PLANNED ENVIRONMENTAL UNIT, LOCATED ON THE EAST SIDE OF BAXTER RD. NORTH OF AUGUST HILL DR. AND SOUTH OF WILD HORSE CREEK RD. **(FIRST AND SECOND READINGS – PLANNING COMMISSION RECOMMENDS APPROVAL)**
