- A. [BILL NO. 2950](#)** AMENDS CITY ORDINANCE CHAPTER 5, ANIMALS & FOWL, ARTICLE 1, SECTION 5-2, FEEDING OF WILDLIFE
(**SECOND READING; PUBLIC HEALTH AND SAFETY COMMITTEE RECOMMEND APPROVAL**)
