II. PROJECT PRESENTATIONS:

- A. Claddagh Irish Bistro/Westfield Shoppingtown Chesterfield:** Amended Architectural Elevations for a regional shopping center in a "C-8" Planned Commercial District located south of Highway 40/Interstate 64.

Assistant Director of Planning Annissa McCaskill-Clay presents amended elevations for a previously reviewed and approved project for the redevelopment area of the Westfield Shoppingtown. This project is for an Irish Pub in the space east of The Cheesecake Factory. Materials consist of stone, brick, and EIFS. After review of the project, the Department of Planning found no outstanding issues.

- 2.) **Revamped castle theme with toned down details.**

B. Pfizer/Monsanto: Architectural Elevations, Landscape Plan, Lighting Plan and Site Development Plan for a 200.51 acre parcel zoned C-8. The site is located west of Chesterfield Parkway north of the intersection with Swingley Ridge Road.

Project Planner Nick Hoover presents the project for a six-story (6) 322,500 sq.ft. building continuing in the same pattern and form as the existing building. After review of the project, the Department of Planning found no outstanding issues, but noted that the curtain wall design connecting the buildings will be determined at tonight’s meeting.

Project Planner Nick Hoover presents the project for three (3) new multi-family buildings (73,698 sq.ft.) identical to the existing structures. Materials will consist of the same brick, veneer, wood balcony, and asphalt shingle roof. After review of the project, the Department of Planning found no outstanding issues.

After review of the project, the Department of Planning found no outstanding issues and noted that proposed signage will be reviewed in a separate process.
