**I. Call to Order/Agenda – Darcy.**

**A. Sign-in Attendance. *Reviewed Libbey’s emailed documents: Abi/Bow volumes, NWF CHTeam, National Telecon Minutes, City Newsletter articles Sep, Oct, Nov, 2011; native flora list for Riparian area of Eberwein Park.***

**II. “Mainstreaming Green” Projects: Discussions/and-or Actions.**

**A. Presenter: Mr. John Haasis, P.E., M.H.A, St. Louis County/Dept. of Health – Solid Waste Management Program, Program Manager. Topic: Solid Waste Diversion from Landfill Status in St. Louis County: How is it calculated?**

*The purpose of his efforts is to regulate trash from a health perspective and pay more attention to the economics of recycling. From 2003 to 2010 the County has increased landfill diversion from 29% to 55%. Partnering with Curbside Value will hopefully enable the County to make additional progress in recycling and landfill diversion.*

**B. CFM Grant: Repairing the Riparian: Planting-Playing-Picnicking at the NEW Eberwein Farm Park! Sat., Oct. 15, 2011, 11 AM – 1 PM – Libbey, Darcy.**

1. Boy Scout Volunteers – Terry. *Terry will pursue getting 15 volunteers from the three local Boy Scout troops.*
2. Native Flora Planting List/cost – vote. *We approved the list of trees from which to make purchases.*
3. Kites/cost update; to preassemble or not – Scott, Jeff. *48 kites of various kinds have been ordered. String is included. We will obtain the necessary crepe paper and tape for the tails. We will assemble a kite to ensure there are no problems. Estimate total cost of the kites is \$85. Home Depot was notified that they do not have to provide string.*
4. Food choices/cost – a) Need subcommittee b) Dierbergs’ donation. *Members will scope out the choices. We need to coordinate pick-up from Dierbergs.*
5. Flyers/posters/cost. Draft due 8/25 meeting. *Libbey disseminated the proposed flyer. Amendments to the flyer will be made..*
6. Budget remaining. *\$1425 less \$1000 for native flora and \$85 for kites = \$340 for food/flyers, etc.*
7. Conservation Handouts – *Will be made available.*
