The minutes of the January 15, 1990, Public Hearing meeting, with regard to cable television franchise, were submitted for approval. A motion was made by Councilmember Bute, seconded by Councilmember Schroeder, to approve the minutes. A voice vote was taken, with a unanimous affirmative result, and the motion was declared passed.

Mr. Dan Kazanas, who resides at 1153 Richland Drive, spoke in opposition to Ordinance #308, which deals with political signs. Acting-Mayor Fawcett indicated that Bill #404, which will be introduced under the Legislation portion of the agenda, will repeal Ordinance #308.

Acting-Mayor Fawcett reported on the process in place for appointments to the various Boards and Commissions.

Acting-Mayor Fawcett next introduced Resolution #82, which calls for the Missouri State legislature to act to prohibit the construction of a hazardous waste incinerator in the Times Beach area. A motion was made by Councilmember Hartman, seconded by Bute to adopt Resolution #82. A voice vote was taken with a vote of 7 - 1 (Councilmember Flachsbart abstained) and Resolution #82 was declared passed.

Acting-Mayor Fawcett next introduced Resolution #83, which supports Senate Bill #769 relating to the West County Regional Transportation Improvement Committee and establishing a Board for a special taxing district. A motion was made by Councilmember Hrabko, seconded by Councilmember Bute to adopt this Resolution. A voice vote was taken with a unanimous affirmative result and Resolution #83 was declared passed.

Acting-Mayor Fawcett next placed the name of Jamie Cannon in nomination to fill the vacancy on the Planning Commission created by the resignation of Mr. Ed Bidzinski. This term will expire April 6, 1992. A motion was made by Councilmember Hrabko, seconded by Councilmember Hartman, to approve this nomination. A roll call vote was taken with the following results: Ayes - Schroeder, Hartman, Hrabko, Fawcett. Nays - Hathaway, Flachsbart, Bute, Hurt. Acting Mayor Fawcett voted "Aye" and the motion was declared passed.

Acting-Mayor Fawcett next introduced a Proclamation, which endorses the City of Chesterfield's support for the 2004 St. Louis Committee, the organization promoting the World's Fair on the centennial of the 1904 World's Fair held in St. Louis. A motion was made by Councilmember Hartman, seconded by Councilmember Bute, to approve this Proclamation. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Acting-Mayor Fawcett next placed in nomination the name of Kathy Rinaberger for re-appointment to serve on the Chesterfield Human Rights Commission. This is a three (3) year term and will expire on March 6, 1993. A motion was made by Councilmember Hartman, seconded by Councilmember Bute, to approve this re-appointment. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

#### COUNCIL COMMITTEE REPORTS

##### Planning and Economic Development

Councilmember Hrabko, Chairperson of the Planning and Economic Development Committee, stated that Bill #'s 406 - 411 will be considered for adoption later in the agenda under the Legislation portion.

Councilmember Hrabko announced the Planning Commission will review, and possibly Page 4

approve, the Comprehensive Plan at its next meeting scheduled for February 12, 1990. Councilmember Hrabko applauded the citizens and the Planning Commission who worked so diligently on this project.

Councilmember Hrabko next announced the next meeting of his Committee has been scheduled for February 7, 1990, at 5:45 P.M.

#### Finance and Administration

Councilmember Hartman, Chairperson of the Finance and Administration Committee, presented Resolution #80, which authorizes the City Administrator to execute the lease/purchase agreement between the City of Chesterfield and McDonnell Douglas Finance Corporation for the financing of the new office furniture.

A motion was made by Councilmember Hartman, seconded by Councilmember Hrabko, to approve this Resolution. A voice vote was taken with a vote of 7 - 0 - 1 (Councilmember Flachsbart abstained) and Resolution #80 was declared passed.

#### Public Works/Parks

Councilmember Bute, Chairperson of the Public Works/Parks Committee, announced that the next meeting of her Committee has been scheduled for February, 8, 1990, at 5:30 P.M.

#### Public Health and Safety

Councilmember Flachsbart, Chairperson of the Public Health and Safety Committee, reported that Bill #403 will be introduced for consideration under the Legislation portion of the agenda.

Councilmember Flachsbart announced the next meeting of his Committee has been scheduled for February 12, 1990 at 7:00 A.M.

#### REPORT OF THE CITY ADMINISTRATOR

City Administrator reported that eight (8) proposals, meeting the bid specifications, have been received for the purchase of one (1) 3/4-ton pickup truck for the Public Works Department. The bids ranged from a low, submitted by Johnny Londoff Chevrolet, of \$16,783.00 to a high of

\$18,908.00 submitted by Broadway Ford Truck Sales. Based on the fact that the bids have been reviewed and approved by Director of Public Works/City Engineer Bill Hawn and Finance Director Jan Kluba, City Administrator Herring echoed their recommendation of recommending the low bid of \$16,783.00 submitted by Johnny Londoff Chevrolet for the purchase of one (1) 3/4-ton pickup truck be approved. City Administrator Herring reported that Bills #'s 397 and 398, which will be considered for adoption under the Legislation portion of the agenda, are necessary to replace the Resolution #'s 78 and 79, adopted at the January 15, 1990, City Council meeting, as required by the Boundary Commission. City Administrator Herring announced that he and Director of Planning and Economic Development Jerry Duepner will make a presentation to the Boundary Commission on February 13, 1990, concerning Chesterfield's annexation proposal.

City Administrator Herring announced that the Government Center will be closed February 19, 1990, in observance of Washington's Birthday.

In view of the fact that the Government Center will be closed on Monday, February 19, 1990, City Administrator Herring reminded those in attendance that the next meeting of the City Council has been scheduled for Tuesday, February 20, 1990.

City Administrator Herring next announced that a meeting will be scheduled in the near future for all candidates for office and Staff to provide information and answer questions about the various issues that the City is involved with at the present time.

A motion was made by Councilmember Hartman, seconded by Councilmember Schroeder, that the meeting be adjourned. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. The meeting was adjourned at 8:25 P.M.
