MEETING OF THE CITY COUNCIL OF THE CITY OF CHESTERFIELD
AT 16052 SWINGLEY RIDGE ROAD
APRIL 20, 1999

The meeting was called to order at noon.

Acting-President Pro Tem Linda Tilley stated that the purpose of the meeting was to enable approval of the sale of the Phase II Propositions "R" & "S" general obligation bonds.

Acting-President Pro Tem Tilley introduced Sondra Martin Denk, Vice-President Investment Banking, A. G. Edwards, who reported on the nine bond bids that were received. The bond rates are as follows:

Councilmember Streeter made a motion, seconded by Councilmember Casey, to accept the 4.69% interest rate as submitted by NationsBanc Montgomery Securities LLC. A voice vote was taken with an affirmative unanimous result and the motion was passed.

BILL NO. 1667 AN ORDINANCE AUTHORIZING AND DIRECTING THE ISSUANCE, SALE AND DELIVERY OF \$15,125,000 PRINCIPAL AMOUNT OF GENERAL OBLIGATION BONDS, SERIES 1999, OF THE CITY OF CHESTERFIELD, MISSOURI; PRESCRIBING THE FORM AND DETAILS OF SAID BONDS; PROVIDING FOR THE LEVY AND COLLECTION OF AN ANNUAL TAX FOR THE PURPOSE OF PAYING THE PRINCIPAL OF AND INTEREST ON SAID BONDS AS THEY BECOME DUE; AND AUTHORIZING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH (SECOND READING)

Acting-President Pro Tem Tilley made a motion for the second reading of Bill No. 1667. Councilmember Streeter seconded the motion. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 1667 was read for the second time. A roll call vote was taken for passage and approval of Bill No. 1667, with the following results: Ayes – Durrell, Streeter, Grosser, Casey, Tilley and Brown. Nays - None. Whereupon Acting-President Pro Tem Tilley declared Bill No. 1667 approved, passed it and it became **ORDINANCE NO. 1513**.
