COMMUNICATIONS AND PETITIONS

Mr. John Walters, who resides at 15204 Kempwood Drive, requested that City Council postpone the approval of the nomination of Ms. Susan Clarke to the position of Prosecuting Attorney until a later date.

INTRODUCTORY REMARKS

Mayor Jack Leonard placed the name of Mr. Richard K. Brunk in nomination for Municipal Judge, effective June 30, 1994, which is the date of Judge Michael Doster's resignation. A motion was made Councilmember Hilbert, seconded by Councilmember Tilley, to approve the nomination. A roll call vote was taken with the following results: Ayes - Flachsbart, Hilbert, Levinson, Hurt, Politte, Tilley. Nays - None. The motion was declared passed. Mr. Brunk's term will expire on June 30, 1998.

Mayor Leonard next placed the name of Ms. Susan Clarke in nomination for Prosecuting Attorney, effective retroactively to June 1, 1994. A motion was made by Councilmember Levinson, seconded by Councilmember Hurt, to approve the nomination. A roll call vote was taken with the following results: Ayes - Hilbert, Levinson, Hurt, Politte, Tilley. Nays - None. Abstained - Flachsbart. The motion was declared passed. Ms. Clarke's term will expire on June 1, 1998. It was noted that Mr. Brunk will continue to serve as Prosecuting Attorney until June 30, 1994.

Mayor Leonard next announced that candidate filing for the vacancies in Ward II and Ward IV will begin on Monday, June 13, 1994, at 8:00 A.M. and conclude on July 1, 1994, at 5:00 P.M. The municipal election has been scheduled for August 2, 1994.

#### REPORT OF THE CITY ADMINISTRATOR

City Administrator Mike Herring reported that RHB St. Louis, Inc. d/b/a Red Hot and Blue, located at 100 Four Seasons Shopping Center, has submitted an application requesting a liquor license to sell all kinds of intoxicating liquor by the drink for consumption on the premises and Sunday sales. The application has been reviewed and approved by Chief of Police Ray Johnson and Director of Planning Jerry Duepner. A motion was made by Councilmember Politte, seconded by Councilmember Tilley, to approve issuance of the liquor license. A voice vote was taken a unanimous affirmative results (6 - 0) and the motion was declared passed.

#### ADJOURNMENT

Mayor Leonard entertained a motion to adjourn the City Council meeting to go into Executive Session for the purpose of discussing litigation. A motion was made by Councilmember Hurt, seconded by Councilmember Politte, that the meeting be adjourned.
