At the request of Councilmember Ohley, City Attorney Graville explained the process involved when authorizing eminent domain.

Councilmember Hurt made a motion, seconded by Councilmember Monachella, for the first reading of Bill Nos. 3330 through 3334. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill Nos. 3330-3334 were read for the first time.

Councilmember Ohley made a motion, seconded by Councilmember Moore, to authorize the City Administrator to execute a five-year agreement with Republic Services for solid waste management. Discussion ensued. A roll call vote was taken with the following results: Ayes – Mastorakos, Monachella and Moore. Nays – McGuinness, Keathley, Hurt, Ohley and DeCampi. Mayor Nation declared the motion failed.

Director of Public Works/City Engineer Jim Eckrich asked for direction on how to proceed. Councilmember Keathley made a motion, seconded by Councilmember DeCampi, to direct Staff to prepare bid documents for review by the Planning and Public Works Committee. A voice vote was taken with an affirmative result (Councilmembers Monachella and Mastorakos voted “Nay”). Mayor Nation declared the motion passed.

Councilmember Hurt announced that the next meeting of this Committee is scheduled for Thursday, January 21, at 5:30 p.m.


