# VII. SITE PLANS, BUILDING ELEVATIONS, PLATS, AND SIGNS

A. <u>1330 Schoettler Road (Church of the Resurrection)</u>: Amended Site Development Plan and Amended Architectural Elevations for a church located on a 5.2-acre tract of land located east of Schoettler Road and south of South Outer 40 Road, zoned "R2" Residential District.

<u>Commissioner Staniforth</u>, representing the Site Plan Committee, made a motion recommending approval of the Amended Site Development Plan and Amended Architectural Elevations for <u>1330 Schoettler Road (Church of the Resurrection)</u>. The motion was seconded by <u>Commissioner Wuennenberg</u>.

<u>Commissioner Wuennenberg</u> noted that the utility meter is situated near the street and questioned whether it could be moved closer to the building. <u>Mr. Mike Vorwerk</u> of Civil Engineering Design Consultants explained that such a move would be rather difficult as it involves over 70 feet of conduit going underneath an existing parking lot and through existing retaining walls.

<u>Commissioner Wuennenberg</u> stated that he wanted this information available for Council's review, if deemed necessary, and also asked Mr. Vorwerk to share this concern with the property owner.

# The motion to approve <u>passed</u> by a voice vote of 8 to 0.

B. <u>Spirit Valley Business Park, Lot 6 (SDSP)</u>: Site Development Section Plan, Landscape Plan, Lighting Plan and Architectural Elevations for an office/warehouse building located on a 3.3-acre tract of land located west of Spirit Valley West Drive, zoned "PI"-Planned Industrial.

<u>Commissioner Staniforth</u>, representing the Site Plan Committee, made a motion recommending approval of the Site Development Section Plan, Landscape Plan, Lighting Plan, and Architectural Elevations for <u>Spirit Valley Business Park, Lot 6</u>. The motion was seconded by <u>Commissioner Wuennenberg</u> and <u>passed</u> by a voice vote of 8 to 0.

### Request

<u>Planner Shilpi</u> Bharti stated that the applicant is requesting to rezone three parcels from "PUD" to "E-1AC" Estate District to allow *school* as a permitted use.
