Chesterfield's Second Annual 4th of July Celebration & Fireworks Display

In the spirit of community and civic pride, the City of Chesterfield will host its second annual 4th of July Celebration and Fireworks Display on Wednesday, July 4. The free event will be held on the parking lot of Westfield Chesterfield on the northwest side of the mall between Macy's and Dillard's. This viewing area will include children's entertainment beginning at 7 p.m. and the Ralph Butler Band taking the stage at 7:30 p.m. The fireworks display will be presented by Fireworks Spectacular beginning at 9:30 p.m. and will end at approximately 10 p.m.

Attendees are encouraged to bring their own lawn chairs or other seating for their comfort and ease of viewing. The display will be set up on land owned by Sachs Properties to the west of the viewing area. There will be limited food vendors on site, and participants can bring their own food and beverages. The following items will not be permitted at the event: glass bottles, aerosol cans, laser pens/pointers, weapons of any kind, illegal substances, barbeque grills, tents, fireworks, and pets (except for service animals).

Chesterfield Mayor John Nations says, "We're pleased to be able to bring this event to our residents for a second year. It is an excellent opportunity to bring families together in Chesterfield to enjoy the holiday in a fun, safe atmosphere."

From the Mayor

A Family Friendly Summer

Have you made your plans for summer activities yet? There's so much to see and do within Chesterfield that can involve the entire family and many more exciting things planned for our use in years to come. I would encourage you to take a closer look at what the Chesterfield Parks and Recreation Department has to offer.

Approved by the voters in 2004, Proposition P established a one-half cent sales tax in which all of the proceeds are dedicated exclusively to parks and recreation. I am pleased to report that we have delivered on that promise to complete, or have under contract, all of the Tier I project improvements in 2007. These projects included improvements to the Chesterfield Valley Aquatic Center, Chesterfield Valley Athletic Complex and Levee Trail in the Chesterfield Valley, all of which contribute to an increased quality of life for our residents.

Summertime and water activities go hand-in-hand, so be sure to visit the **Chesterfield Aquatic Park** to see what's new. We have been working to bring you over \$3 million in improvements to this area since October; however, weather and inspection issues have caused us to delay the opening of the park. It is estimated that the first day of operations will be June 16 and that ALL amenities will be open and operational by June 23. Be assured the improvements are worth the wait, with residents now being able to enjoy a 250-foot Lazy River, two additional slides, and a new children's play unit. Additionally, improvements have been made to the leisure and competition pools. This facility, located within Central Park on Lydia Hill Road, will provide hours of summer fun for the entire family.

Why not pack a picnic and take the family to Central Park and enjoy the beautiful, natural surroundings and play areas for children. Greater things are in the works to expand Central Park to encompass 38 acres, and I'm sure you've noticed all the clearing going on in this area around the West County Library and YMCA. Proposition P Tier I improvements for Central Park include site clearing and grading for future improvements which could include walking trails, two recreational lakes, an amphitheatre, additional pavilions, a boathouse and additional parking. Just picture fishing off the banks of the lake or enjoying a paddle boat ride on a warm summer day.

Nearly anyone with a child involved with sports has visited the **Chesterfield Valley Athletic Complex (CVAC)**—many of you volunteer your time to coach these teams. Several improvements have been made to the CVAC through funds received from Proposition P including the lighting of five baseball/softball fields; construction of the Miracle Field, two football fields, three soccer fields, and two multi-purpose fields; additional parking; utility extensions allowing the addition of

concession and restroom facilities; landscaping; curbing and sidewalks; creating a trail head for the Levee Trail; additional pavilions; and additional signage. This highly sought-after venue is host to national tournaments throughout the year, as well as regional and local tournaments.



Additionally, the City purchased 30 acres of land immediately east of the existing CVAC, which will be used for the development of a Parks Administration and Maintenance Facility, and for the future development of athletic fields and parking. If you haven't experienced this sports complex and all it has to offer sports fans of all ages, I would encourage you to see what it has to offer. We are continually working to seek out other appropriate tracts of land throughout the City in an effort to preserve green space and to establish future parks.

Another project made possible by Proposition P is the design and construction of a Levee Trail system. The City has partnered with the Great Rivers Greenway District, and is currently working with consultants on the planning and design of a trail system which will be located on or near the Monarch-Chesterfield Levee in the Valley. Construction of the first section of the trail will extend from the Summit Ice Complex west to the Chesterfield Valley Athletic Complex. Construction is scheduled to begin this summer and should be completed in the fall.

While you have allowed us through Proposition P to bring many new capital improvements to you, there are many other exciting events happening throughout this summer. I am pleased to announce that we will once again be presenting a **4th of July Celebration** filled with music and family fun (see related article in this issue of "The Citizen".) The event exceeded our attendance predictions last year and the show itself was outstanding. I'm sure you can expect an even more spectacular show from Fireworks Spectacular this season.

New to Chesterfield this summer is **Movies on the Plaza**. The City will be showing movies at sunset on the plaza in front of City Hall on the fourth Friday of each month from June 29 to September 28, with the movie "Happy Feet" being the first screening on June 29. What a unique way to spend a summer evening by watching a family friendly movie outside!

As you can see, there are many outdoor activities this summer that offer something for everyone. I encourage you to take advantage of all the great city of Chesterfield has to offer. Please have a safe and enjoyable summer.

Philip and Kay Folsom Selected as Chesterfield Citizens of the Year

Volunteering Couple Earns Recognition

Mayor John Nations presented Philip and Kay Folsom with the 2006 Chesterfield Citizen of the Year Award at the City Council meeting on March 19. The individual nominating the Folsoms, Gerald Right, stated that, "They are consummate volunteers for the City of Chesterfield, and their many endeavors have enriched the quality of life for all citizens."

Upon moving to the area in 1983, the Folsoms quickly became involved in volunteering for their community and even worked to help incorporate the City of Chesterfield in 1988. In 1989, Phil was appointed to and chaired for three years the Citizens Interaction Committee (CIC), which was responsible for establishing programs designed to involve the citizens of the new city. Among other things, the CIC created the City's newsletter, the "Chesterfield Citizen", and established the Citizen of the Year Award. Phil was appointed to the City's Police Personnel Board in 1997, where he was elected Chairman in 2002 and still serves in this capacity, assisting in interviewing new applicants for the police department and hearing arbitration matters. He also serves as a trustee of his subdivision, The Forest, and works to organize many neighborhood activities.

Kay Folsom was appointed to the Chesterfield Beautification Committee and was elected Chairperson in 2002. Under her leadership, the Committee held its first Garden Tour in 2005 and again in 2006, wherein the profits were donated toward

City beautification projects, including the planting of landscaping in the medians along Clarkson and Olive boulevards, and also included a volunteer bulb planting day at City Hall in the fall of 2006. Additionally, Kay was appointed to the Board of Chesterfield Arts in 2000, where she still actively participates in their community and fundraising activities. Both she and Phil especially enjoy working with children in the arts programs and events.

For the past three years, both Phil and Kay have volunteered with OASIS, a national nonprofit educational organization providing intergenerational tutoring to help young children build reading skills and positive attitudes toward learning.

"Chesterfield is a better place because of the time and efforts of the Folsoms," said Mayor John Nations. "It is the contributions of people like this all throughout our community that make Chesterfield a city of volunteers, who, through their work, make the quality of life better for us all."

What's Coming to Town? Clock Tower Plaza

This month's featured development in "What's Coming to Town?" is a retail development known as Clock Tower Plaza located on Chesterfield Commons East Drive between Edison and Chesterfield Airport roads. This project is owned and developed by Schifano and Sons LLC, which also owns Petropolis in Chesterfield Valley. John Schifano is project manager. Plans for the plaza include a collection of upscale specialty shops not currently found in the Chesterfield market, showcasing a Mediterranean style of architecture and featuring a 40-foot-tall clock tower, with the clock being eight feet in diameter. Businesses should be opening in the late summer.

"The boutique-style destination tenants will set this development aside from others in the area," say leasing agents Paul Nagel and Rudy Stinnett of Grubb & Ellis/Gundaker Commercial. "The shops will be independently owned and will feature items such as ladies accessories, home decor, and perhaps a coffee shop, which would group around an anchor tenant, such as a full-service spa."

Sustainable Gardening Practices To Empower Our Pollinators

Help the health of the pollinators—butterflies, bees, moths, hummingbirds, and many others. Join with other nations, states, scholars, and Missouri beekeepers who note significant 'bee and hive disappearance syndrome', stemming from both known and unknown factors. Set aside some space in the yard or existing gardens. Consider planting native and non-native flora (separate or together), environmentally-friendly hosts to butterflies, hummingbirds and song-birds! Compost yard waste for this special area and eliminate pesticides as butterflies are the most environmentally-sensitive pollinators. Take a summer stroll to City Hall for copies of butterfly and pollinator booklets and flyers, including layouts for gardening ideas. Don't Waste Your Trash: Recycle It!

Much of what remains in our current waste stream destined for landfills, another diminishing resource, can be recycled curbside. In 1990, we recycled 10% of this waste stream, and in 2003, we averaged 45% in our Solid Waste Management District. Increasing the recycling rate in the United States from 30% to 60% would save the equivalent of 315 million barrels of oil each year! By unanimous vote, St. Louis County Council recently stipulated a 50% diversion rate by 2010 or sooner.

Single Stream Recyclables, collected curbside in Chesterfield, include all plastics #1-7 (no #6), paper fibers including junk mail, phone books, paperbacks and broken-down cardboard, metal cans, glass, packaging, and so much more. **Remember that the greatest benefit of recycling relates to the conservation of energy and natural resources.** Search the word "recycling" in the InfoFinder Box on the City's website at www.chesterfield.mo.us or walk up to City Hall for a copy of "Think Resources NOT Trash!" and other recycling information.

Chesterfield Police Utilize New Mode of Transportation

Segways Being Used to Patrol Chesterfield Mall and Shopping Centers

With the recent acquisition of two Segway Personal Transporter machines, the Chesterfield Police are now patrolling the Westfield Chesterfield Mall and the Chesterfield Commons more efficiently and effectively. The futuristic-looking, two-wheeled, one-person machines have received a positive response from citizens and business owners alike. Michael Staenberg of THF, developer of Chesterfield Commons, states that he's excited about the use of the Segways in the Commons. "We have a world class shopping center in Chesterfield, and this addition to our police protection will only enhance safety and security for our patrons."

The battery-operated Segways were purchased with drug forfeiture funds and will be used to patrol and navigate business areas and special events, such as the 4th of July Celebration and the St. Louis County Fair and Air Show.

"The Segways will provide a unique mode of transportation that will enable officers to quickly maneuver in crowded areas both indoors and out. Additionally, they will provide them a greater ability to see above the crowds in populated areas," stated Chesterfield Chief of Police Ray Johnson.


Wanted: Good Pet Neighbors

By municipal law, your pet must be on a leash or confined on your property. In addition, it is against City ordinances to allow your dog to bark continuously. Likewise, a "pooper scooper" law is in effect.

Breaking these ordinances can result in a fine or more serious penalties. So, please be a caring and responsible pet owner and neighbor.

City Of Chesterfield Fireworks Ordinance

As the 4th of July approaches many people will enjoy the holiday with back yard barbecues, swimming, family fun and other summer activities. Another spectacular event to enjoy this year will be the City of Chesterfield's second annual fireworks display on Wednesday, July 4th beginning at 9:30 p.m. at Westfield Chesterfield.

However, it's important to know that Chesterfield's City ordinance has long prohibited individuals from either selling or discharging fireworks, except by permit. Fireworks can be dangerous at times and can cause both personal injury and property damage. The Chesterfield ordinance pertaining to fireworks reads as follows:

- (a) It is unlawful for any person to manufacture, sell, offer for sale, ship or cause to be shipped into the corporate limits of the City of Chesterfield, any item of fireworks. This section applies to non-residents as well as residents of the City.
- (b) Any person possessing or transporting special fireworks into the corporate limits of the City of Chesterfield for the purpose of conducting a special fireworks display shall be licensed by the state fire marshal as a distributor in accordance with Section 320.126 RSMo, 1985, as amended.
- (c) Before any permit for a special fireworks display shall be issued by the City Administrator, the fair association, amusement park, organization, firm, or corporation making the application therefore shall furnish proof of financial responsibility to satisfy claims for damages to property or personal injuries arising out of any act or omission on the part of such person, firm or corporation or any agent or employee thereof.

Sec. 13-23. Explosion, ignition, discharge unlawful. It is unlawful for any person to explode, ignite or discharge any articles of fireworks within the corporate limits of the City.

So, join us for a safe and spectacular fireworks display on July 4th at Westfield Chesterfield!

Sidewalk Problems and Repairs

The City of Chesterfield's commitment to provide safe and continuous sidewalks throughout the City remains very strong. With nearly 300 miles of sidewalks in the City, this task is very demanding.

Sidewalks are built on slabs; in other words, they do not have a foundation under them. Thus, they are vulnerable to the freeze-thaw cycle, which can sometimes cause heaving. Trees located adjacent to sidewalks can also cause problems. As the tree grows, the roots raise the sidewalk and cause displacement. Lawn edgers used down the sides of the sidewalk allow water to flow underneath the sidewalk, causing the supporting base material to wash out, and underground lawn sprinklers continuously saturate the base material, both of which can cause movement of the sidewalks.

Several maintenance methods are used by the Public Works Department to address sidewalk displacement problems.

Sidewalks with a displacement of one inch (+/-) are being addressed with the sidewalk grinder, which restores a smooth transition from slab to slab. Sidewalks with a displacement greater than one inch are prioritized and placed on a list for removal and replacement, with first priority given to areas with a displacement of over three inches. In some cases, asphalt may be placed to create a temporary ramp, which eliminates the separation until the sidewalk can be permanently repaired. Only sidewalks with displacements are addressed. The City currently does not have the ability to address small cracks or surface defects.

By continuing to direct in-house efforts, as well as contractual efforts, the City has steadily reduced the number of necessary sidewalk repairs. However, sidewalk repairs, by their very nature, will continue to require an enormous commitment of resources and manpower.
