**COURT ORDER**  
**VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES**

Pursuant to 479.050, RSMO, Supreme Court Rule 37.495, the undersigned Municipal Judge of the Chesterfield Municipal Division hereby orders that the following designated offenses shall be prepayable to the City of Chesterfield Violations Bureau. In such cases, if the fine and costs total is paid before the court date, no court appearance is necessary.

**ANY VIOLATION RESULTING FROM AN ACCIDENT OR IN A CONSTRUCTION ZONE OR ACTIVE SCHOOL ZONE SHALL REQUIRE A COURT APPEARANCE AND IS NOT PREPAYABLE**

Court Costs

In accordance with Missouri statutes and city ordinances, the total amount of court costs charged shall be \$33.50. This includes Basic Court Costs of \$12.00, Crime Victim's Compensation Surcharge of \$7.50, Local Law Enforcement Training Fund of \$2.00, State Peace Officers Training Fund of \$1.00, Domestic Violence Shelter Surcharge of \$2.00, Biometric Verification Surcharge of \$2.00 and Court Automation Fee of \$7.00 for a total of \$33.50. Court costs shall be paid in addition to any fine except on violations for which costs are waived by statute and/or ordinance.

The above stated fines reflect the prepay amount if paid out of court at the Violations Bureau in a timely fashion. In court, the Judge may assess a fine from \$5.00 to \$1,000.00 (or a maximum of \$225.00 regarding Minor Traffic Violations as defined by 479.350) and/or one (1) day to ninety (90) days in jail for a violation not defined as a Minor Traffic Violation, per charge.
