All fees must be paid in full at time of reservation. All reservations must be made two (2) weeks in advance.

Cancellation and weather policy: 25% administration fee will be charged for patrons canceling their party up to three days prior to the party. Full refund will be awarded if the City of Chesterfield cancels the party due to weather or any other reason before the event starts. If less than one hour has passed, and food and drink has been provided, patrons will receive a free pool pass, but not a refund. If over an hour has passed, and the pool is closed due to weather, no refund will be given. We will provide our best efforts to reschedule.

GUIDELINES TO AN ENJOYABLE PARTY:

- 1) Use of the reserved Pool Party Area for two (2) hours. **Party area is for pool parties only.**
- 2) Plates, spoons, and napkins will be provided.
- 3) Food and beverage must remain in the concession area provided. No tables or fixtures will be moved, removed, or rearranged.
- 4) All persons entering Chesterfield Family Aquatic Center will be counted as a member of the party regardless of their swimming status. **Additional guests will pay appropriate daily fees.**
- 5) All guests are expected to follow the facility rules.
- 6) Lockers are available. You must provide your own locks or can rent one for \$1.
- 7) A ratio of one (1) swimming adult to every five (5) children under the age of five (5) must be met for all groups at all times.
- 8) A ratio of one (1) swimming adult to every eight (8) children for ages five (5) and up.
- 9) You are responsible for cleaning up after your party to include tabletops and grounds in the designated party area. All decorations need to be removed and trash disposed of in proper receptacles. Decorations may not be taped to the building or fencing.

WHAT YOU CAN PROVIDE:

- 1) Cake (No storage available to refrigerate or freeze the cake, so please plan accordingly. Cake must remain in party area.)
- 2) Candles, lighter, and server for the cake
- 3) If a special theme is desired, your own plates, cups, napkins, and utensils
- 4) Gifts, Goody Bags or Party Favors (No storage available on the premise for gifts. Please plan accordingly.)

POOL PARTY RULES:

- 1) Pool parties must be booked at least two (2) weeks in advance and are made on a first-come, first-served basis.
- 2) You must be twenty-one (21) years of age to book a party.
- 3) No glass bottles or containers may be brought into the pool area.
- 4) Lessees will be held responsible for all damages to the facility during the scheduled event resulting from their usage.
- 5) The proposed activity or use is not to reasonably anticipate violence, crime or disorderly conduct.
- 6) The Lessee is responsible for all items in the pool party area (personal items, presents, cake, etc.). The city is not responsible for any lost or stolen items.

GENERAL RULES:

- 1) Swimsuits with rivets, zippers, buckles, or any other type of plastic or metal will not be allowed to go down the slide.
- 2) Swim diapers are required for all infants and toddlers swimming. No disposable diapers of any kind will be allowed.
- 3) Floatation devices must be Coast Guard approved and labeled as such. All children wearing floatation devices must remain within arms' reach of a swimming adult and will be restricted to the shallow-water areas of the facility.
- 4) No rafts, tubes, or other floatation devices may be brought into the facility, with the exception of noodles. No nerf, other water absorbent balls, or water guns will be allowed.
- 5) No tobacco products, (smoking, chewing and vaping) will be allowed inside the facility.
- 6) Chewing gum will not be allowed inside the pool area at any time.
- 7) Running, rough play, roughhousing, and obscene gestures and language are not allowed. Determination that these acts are occurring is left to the discretion of the pool staff.
- 8) Swimmers with contagious conditions or open wounds will not be allowed admission to the facility.
- 9) Management reserves the right to modify these rules as situations dictate for the safety of the public. Failure to follow directions from pool staff will result in removal from the facility.
- 10) Please refer to signs around the facility for further rules.
