


Newest public art sculpture "Flow" to be installed in Central Park

The City of Chesterfield will install the newest public art sculpture, "Flow," in Central Park by late summer/early fall. The artist, St. Louis-based sculptor Leland Drexler-Russell, was selected as the winner of the Public Art Contest held by the Parks, Recreation & Arts Department in December 2016, for his design of "Flow." Drexler-Russell is a local sculptor with an architectural background. He has created large-scale art since 2009, inspired by his enthusiasm of architecture and mechanical engineering for many of his projects, including "Flow." The sculpture, located near the bridge, contains four broadleaf cattail clusters and a large lotus flower with solar panels located in the petals. These petals powered by the sunlight, harvest energy to the lotus flower creating a glow at night, resting on a lily pad on the lake. The sculptures represents natural elements native to Missouri.

"St. Louis was originally a river city, and Chesterfield shares that same heritage," said Drexler-Russell. "Prior to being called Chesterfield, the area was called Gumbo Flats. I wanted it to be a homage to the river, encompassing the life and vibrancy of the Ozarks."

Leland Drexler-Russell received a bachelor of arts in Environmental Design from The Evergreen State College, Olympia, WA, leading sustainability efforts in the college's housing facilities. His work has appeared at True/False Film Festival, Artica and Art on The Beltline Atlanta, among other venues. Hello again! By the time this message reaches you, summer will be winding down and we will be looking forward to fall. I hope you were able to take in one of our many events, concerts or movies this summer and have been able to walk through the spectacular new Veterans Honor Park. Many residents have told me how much they appreciate the wonderful events we offer that add to their enjoyment of Chesterfield.

Chesterfield Valley Transportation Development District (CVTDD)/ Hockey Support

At the end of my portion of the previous quarterly newsletter, I provided a brief introduction to the Chesterfield Valley Transportation Development District (CVTDD), which was authorized by State law (RsMo 238.200-238.275) and established in 2005. I shared information about the significant transportation/infrastructure projects that have already been funded by the CVTDD. When a TDD is established. State law only allows the registered voters within the proposed district to vote. Accordingly, for the CVTDD, only a handful of subdivisions in the vicinity of Kehrs Mill and Wild Horse Creek Roads ultimately were the approval authority for the authorized projects and parameters of the TDD. Logically, and as permitted by statute, if there are any proposed modifications to the TDD, those same registered voters within district are allowed to approve or disapprove.

The alternative allowed by the State, would be for the commercial property owners within a district to establish and govern a TDD without any voter approval whatsoever. For obvious reasons, we believe that establishing a TDD by a vote of the residents in the TDD is preferable to the alternative of creating a taxing district with little public oversight. Following the recent closure of the Hardee's Iceplex, the local non-profit youth hockey association, Chesterfield Hockey Association, represented by The Staenberg Group and Mia Rose Holdings, approached the CVTDD board to ask for consideration of support to extend the sunset of the TDD tax in order to provide funding for qualified transportation infrastructure associated with the development and construction of a new two-sheet (NHL-sized) ice rink that would serve the local youth hockey community. They did not ask for, and would not be eligible to receive, any TDD funds for construction of the ice rink itself. At the TDD board meeting held June 19, the board (consisting of Chesterfield City Administrator Mike Geisel, St. Louis County Executive Steve Stenger, St. Louis County Assistant Director of Transportation Stephanie Leon Streeter, and myself) unanimously approved Chesterfield Hockey Association's request to put the issue on a TDD Ballot, and let the voters within the district express their opinion. While the total cost of the facility is projected to be just under \$23 million, the proposed ballot proposal limits the TDD support to a maximum of \$7 million, and only if that amount is expended for qualified, eligible expenses. Chesterfield Hockey Association would also seek \$8 million from charitable contributions, and the remainder of the funding would be provided by a conventional loan.

Under different circumstances, it would have been difficult for me as a CVTDD board member to justify support for the ice rink that essentially will be a private, non-profit facility to be partially funded by sales tax dollars paid by shoppers in Chesterfield Valley. However, in addition to recognizing the vacuum that has resulted from the closing of Hardee's Iceplex, we were able to scrutinize their business plan, feasibility study, and an economic impact projection that translates to a direct financial benefit to the City of Chesterfield and, in turn, to our residents.

Unofficial survey conducted showed overwhelming support for CVTDD

It has long been my belief that our City exists in order to provide services to our residents and businesses. Revenues are needed to pay for the services provided and I believe that the revenues (sales taxes) generated by area businesses that are directly attributable to sports complex clientele, will be sufficient to justify TDD support of this project.

Furthermore, if this modification to the CVTDD is approved by the voters in the district (that also allows up to a maximum 15 year extension to the sunset of the collection of the 3/8 cent tax, although realistically the extension is expected to be much shorter) there will be language included in the development agreement to provide at least partial reimbursement to the City of Chesterfield as successor to the CVTDD. I might add that an unofficial survey was conducted with more than 5,000 responses and 95% approval of the CVTDD support.

In conclusion, after thoroughly reviewing the proposal and with specific financial limitations, I believe that it is reasonable and justifiable to allow the voters in the district to approve or disapprove the modification of the TDD resource (without affecting the budget of the City in any way) to assist a non-profit organization to develop and provide a new ice skating facility for our community.

New City Ordinances regarding drones, trash containers and short-term home rentals



This summer, the Chesterfield City Council passed several pieces of legislation that residents should know. Many homeowners are taking opportunities to make a little extra cash by opening up spare rooms for vacation rentals through websites and apps like AirBnB, raising several concerns of Chesterfield residents.

According to Ordinance 2958, it is now illegal for homeowners who occupy or reside in a single-

family dwelling in Chesterfield to rent any portion of their homes for a period of less than 30 days to any person who is not a family member. This legislation was enacted to promote neighborhood safety and aesthetics. Violation of this ordinance is a misdemeanor and could include fines up to \$1,000 and/or jail time.

Drones or "unmanned aircraft systems (UAS)" are becoming more popular and easier to obtain.

Ordinance 2957 places several restrictions on the operation of drones including where, when and for what purpose they can be used. This includes operating only on private property with the property owner's consent and the UAS must stay within the line of vision of the operator. They cannot be operated over large crowds, including City sponsored events, over accidents, fires or crime scenes or for the use of surveillance. Hours of



operation should only be during daylight or within 30 minutes of the official sunrise and sunset. A registration for the UAS issued by the FAA must be presented upon request. If being remotely operated for commercial purposes, FAA licensing must be available or on display.

Ordinance 3153 amended the placement of single-family residential waste containers. Containers are to be stored inside the garage or within any side or rear yard so they are screened or not visible from a street which abuts the property. The maximum number of containers that can be stored is seven at any given time. Containers can be placed at the curb for pick up no earlier than 5 p.m. on the day prior to the collection day and should be removed and returned to storage before midnight on the day of collection.

Chesterfield Night Out scheduled for October 10



Don't leave unused prescription drugs around the house; Take Back Event offers safe and proper disposal

The Chesterfield Police Department is partnering with the Drug Enforcement Administration to conduct a medication take back event on Saturday, October 28, providing a convenient drive-thru collection point in the circular drive located at the main entrance of City Hall. This event will be made available to residents between 10 a.m. to 2 p.m. In the event of rain or inclement weather, the collection point will be located immediately inside the main doors of the building. Residents are encouraged to turn in their unused, unwanted prescriptions and over the counter medicines at the event. Items that will not be accepted at the event include illegal drugs, syringes, intra-venous (IV) solutions or injectables, radioactive medicines, bio-hazardous materials, inhalers or compressed air cylinders, glass thermometers or other medical devices and bulk medication from businesses (such as pharmacies, doctor's offices or hospitals). FAQ on building permits, easements and setbacks

WHERE CAN I PUT MY DECK? (OR ANY OTHER STRUCTURE)

Setbacks and easements are the two most important things to consider when deciding where to build a structure. Every property has a set of structure setbacks from the front, rear and sides of the property lines as determined by either the Unified Development Code or a site specific ordinance. These are codes and ordinances sometimes shown on surveys, which you may have received when you purchased a home, or when a survey was completed. Any structure on your property must be located outside of these setbacks.

Once you know your structure setbacks, you will need to make sure you don't have any easements in your way. An easement is a grant by a property owner to a public or private utility company for the purpose of installation, improvement and maintenance of public or private utilities. If a utility company has infrastructure installed within an easement on your property, there may be a time when the utility company needs to update or repair the infrastructure. They have the right to remove any structure in the way without replacing or repairing it. Occasionally

easements were granted, but utilities were not installed.

Typically, easements are located along the property lines to ensure maximum usability of a property; however, easements are sometimes found through the center of a property if the developer deems it necessary to provide adequate utilities and services to the development. You can find the location of any easement(s) on a survey of the property. They are also available on the City's website through the resident information portal at chesterfield.mo.us/residentinformation-portal.html, or you can contact the Planner-of-the-Day to find the record plat or plan of the development as they are typically shown on these as well.

If you find that there are easements on your property and you wish to build on or over them, you will be required to provide the City with easement releases (sometimes referred to as an encroachment) from all utility companies.

For your convenience, the Planner-of-the-Day can provide you with a contact sheet and checklist of those entities. If a utility company is unable to grant an easement release or encroachment, a building permit cannot be issued.

DO I NEED A PERMIT FOR THE WORK I WANT TO DO?

The best way to find out if a permit is needed is to ask St. Louis County by calling 314.615.7155. It is important to note that St. Louis County requires permits for a wide variety of project types, including plumbing and electrical; however, not all of these require review by the City of Chesterfield as described in this article.

WHAT IS THE PROCESS TO OBTAIN A BUILDING PERMIT?

The process has three major check points: Municipal

Zoning Approval, Building Permit and Occupancy Permit. The first step is to obtain Municipal Zoning Approval from the City of Chesterfield. This application allows the City to check for setbacks, easements, and determine if the City's zoning code is being followed. For this submittal, you will want to submit the fully completed one-page application which can be found in the Forms and Permits section of our website, under Planning and Development Services, along with five copies of your plans. The application form provides quidelines for plan processes and the information needed for the most popular applications; however, a plan reviewer may ask for more information as necessary.

Once the zoning approval is granted, the applicant will be notified that the plans are ready to be picked up. You'll find that you have four of the five plans originally submitted and they are stamped and signed with City of Chesterfield approval. These four sets of plans must then be taken to St. Louis County for a building permit.

The second step is to obtain a Building Permit from St. Louis County. Finally, once the work has been completed and St. Louis County has performed any final inspections necessary, they will send an Occupancy Permit to the City of Chesterfield certifying that the work has been completed according to the approved plans. If necessary, the City will conduct an inspection to ensure the work complies with the City approval, and the City of Chesterfield will release the occupancy permit to the property owner.

HOW LONG WILL THIS ALL TAKE? The City aims to have all Municipal Zoning Approval applications reviewed within three business days. If further information is necessary, the City will generally contact you within that time frame to guide you through the process and let you know of any issues with the application. The City also has a Planner-of-the-Day who is available during working hours (Monday through Friday, 8:30 a.m. to 5 p.m.) to ensure that any questions you have throughout the process can be answered as guickly and efficiently as possible.

Eastern portion of Monarch-Chesterfield Levee Trail closed until 2018

There are two closures on the Monarch-Chesterfield Levee Trail that will be in effect until 2018. The trail adjacent to the Chesterfield Valley Athletic Complex and North Outer 40 Road will be closed at Long Road due to Pump Station work being performed by the United States Army Corps of Engineers. While it was initially planned that the Levee Trail would only close temporarily, the project now requires that the Levee Trail close for the duration of the project, which is expected to be completed by March 15, 2018.

Access to the trail at the former Hardees IcePlex (east trailhead) will be closed during the construction of the new Top Golf development. The trailhead access will be closed until the construction is complete, which we anticipate will be into the summer of 2018. The actual trail is not closed; however, we are encouraging all trail users to access the trail at the western trailhead, located at the Chesterfield Valley Athletic Complex A/B Fields parking lot (see map below). The Monarch-Chesterfield Levee Trail connects to the Katy Trail at the Boone Bridge.

All trails and parks maintained by the City of Chesterfield can close due to maintenance repairs or to eliminate any possible safety hazards at a moment's notice. We encourage all trail and park users to download the Chesterfield Parks, Recreation & Arts free mobile app or to like us on Facebook (City of Chesterfield and/or Chesterfield Parks, Recreation & Arts) for up-to-the minute notifications.

At the corner of Olive Boulevard and Chesterfield Parkway West, construction is underway for Pfizer Bioplace - a \$236 million research campus. This building will contain 295,000 square feet of research and office space, accommodating approximately 470 employees from their current facilities on the Monsanto campus in Chesterfield and at the Missouri Research Park in Weldon Spring, and will add an estimated 80 jobs, with the expansion to be complete in mid-2019. Bugs, Bats and Boy(Scouts)

Support for local Scouts from Chesterfield Parks, Recreation & Arts

In April, the Sellers triplets were in full force when the family dedicated many hours of service to the River's Edge Park in Chesterfield. Andrew, Justin and Nathan, triplets from the Scott & Eileen Sellers family, all received badges from Boy Scout Troop 631. Some of their volunteer service hours were completed while working with Chesterfield Parks, Recreation & Arts Department.

"We have four boys and all were active in Boy Scouts. We wanted our sons to have a way to learn at an early age about the outdoors, especially adding some high adventure. These adventures allowed them to participate in trips they would never have access to these activities on their own," says Eileen Sellers.

The Sellers boys have enjoyed many character-building adventures, from spending the night on a battleship to backpacking and hiking 10 days in the outdoors of New Mexico.

To earn an Eagle Scout badge, boys under the age of 18 are required to volunteer six months or longer, earning at least 21 merit badges and living the principles of the Scout Law daily. The Eagle Scout is the highest advancement rank in Scouting.

Andrew and Nathan logged Boy Scout hours benefiting local schools. Andrew's service, a wooden shed for safety equipment, was made for Shenandoah Elementary School. Nathan's service included mobile carts and stationary shelves for the Parkway Central Middle School Band.

Justin approached Tom McCarthy, Parks, Recreation & Arts Director, regarding potential projects for the department. While there were many projects available, one of the pressing projects involved reducing the mosquitos in the River's Edge Park.

Justin led a team of volunteers (including family members Andrew, Nathan, Ryan, Eileen and Scott Sellers) and logged more than 115 hours from May through August in 2016, constructing and installing bat boxes in trees at River's Edge Park. These Bat Boxes offer hundreds of bats a place to sleep. Although this may make some cringe, bats are helpful to the parks because they can consume as many as 1,200 mosquitoes an hour. Bat houses are built to replicate a bat's natural sleeping environment – tree bark. In the woods, bats sleep between the tree and the bark; these homes provide cover.

Chesterfield Parks, Recreation & Arts appreciates all community members who volunteer their time and effort to improving our parks. Grant provides new recycle containers to be added to **Amphitheater in 2018**

The St. Louis County Department of Public Health Waste Management Program recently awarded Chesterfield Parks,



Recreation & Arts a grant to cover the cost to provide the Chesterfield Parks system with consistent, uniform recycling units at the Chesterfield Amphitheater. The grant from St. Louis County totaled \$11,500 with an additional 10% to be covered with an in-kind match from the Parks. Recreation & Arts Department. The new units will be co-located next to landfill units at the Chesterfield Amphitheater as a pilot project. Significant research has been dedicated to this project by the Chesterfield Citizens Environment Committee, the Parks, Recreation & Arts Department and many others on staff. Our goal is to reduce landfill waste, recycle and reuse materials for a healthier planet. The new recycle containers will be added before the Amphitheater season begins in 2018.





Stemme family remains prominent members of community for generations

Many generations of the Stemme family have lived and worked in Chesterfield, contributing to its development. Charles (Karl) Simon Stemme (b. 1 Nov 1857, d. 3 Mar 1938) was born in Muhlhausen, Germany. He was the son of Frederich Wilhelm (1826-1889) and Willa Stemme and he had four siblings: Hermann, Minnie, Wilhelm, and Caroline. Charles, Hermann and Minnie immigrated to the United States at different times. In 1869, Charles settled in Lake, Missouri near Olive Boulevard and Hog Hollow Road. He worked for area farmers until he had saved enough money to buy his own farmland. He eventually acquired 192 acres. Forty-five acres, located on the north side of Olive Street Road, were purchased from Daniel J. Talbot in the late 1870s. The property included a log house which sat high on a hill at 13969 Olive Street Road in Lake, Missouri. Charles also acquired 50 acres on the south side of Olive Street Road, which is now Westbury Manor Subdivision, and 97 acres in the Missouri River bottoms near the St. Louis County Water Company (Missouri American Water Company today), which the family still owns. The Stemme family raised corn, wheat and soybeans.

Stemme and his bride, Lena Eisenhardt (b. 18 Mar 1866, d. 12 June 1899) began their married life in the log cabin. They gradually added onto the house as their family grew.

They had six children: Charles, Jr.; Louis (1884-1892); Hulda; Frederick (1893-1969); Ernst; and Lillian. Louis contracted scarlet fever at the age of four and died. He was buried in the Arminia Lodge Cemetery located at Highway 141 and Olive Boulevard. Lillian was only two years old when her mother died at the age of thirty-three. Following Lena's death from complications of possibly being gored by a bull, her sister Mary and Mary's husband Herman Kuhlmann raised her youngest daughter Lillian. Lena had been the youngest of seven children.

Besides being a farmer and family man, Charles was a prominent member of the Lake community. He served as the director of Lake School and worked with Felix Oueathem the school board president and clerk William Dierberg to provide his children with a quality education. He was also one of the seventeen founding fathers of St. John's Evangelical & Reformed Church in Bellefontaine at 15370 Olive Boulevard and he served as the church council secretary. Additionally, family legend holds that Charles loaned Mr. Zierenberg money to replace his general store after it was destroyed by fire in 1918. The store was located near the Stemme home on Olive Street Road.

Charles' son Frederick (1893-1969) inherited the house and part of the farm upon his

father's death in 1938. He and his wife I ouise Vohsen (1898-1990) lived in the house and raised their three sons Walter, Stanley, and Wesley. At an early age Wesley began working around the farm. He continued to farm the family's land after his marriage to Arland Lea Resch in 1957. Wesley and Arland have three children: Warren. Jay and Alane. In the bi-centennial year 1976, the farm was proclaimed a century farm because the same family owned it for over one hundred years. The property containing the Stemme house was sold in 1995 and the house was demolished so that Eagle Ridge Subdivision could be built. The original logs were given to the Overland Historical Society for use in the construction of a vintage barn. Wesley's son, Warren continues to farm the remaining Stemme acreage.

Charles, Sr., his wife Lena, their son Frederick and daughter-in-law Louise are buried in the St. John's United Church of Christ Cemetery. Descendants of Charles Simon Stemme continue to be active members of the Chesterfield community.
