

RESOLUTION # 78

**A RESOLUTION ESTABLISHING A BOUNDARY LINE AGREEMENT  
BETWEEN THE CITIES OF CHESTERFIELD, MISSOURI, AND CREVE  
COEUR, MISSOURI**

WHEREAS, a Boundary Commission has been established pursuant to Missouri State Statute for the purpose of overseeing the orderly and systematic incorporation of St. Louis County by the year 2000 in a manner which best meets the needs of existing municipalities and the unincorporated territories of the County; and

WHEREAS, the City Council of the City of Chesterfield, Missouri, supports this goal and wishes to expand its present boundaries in a manner which best meets the needs of this City, our neighboring cities, residents of unincorporated areas contiguous to our boundary, and St. Louis County; and

WHEREAS, the corporate authorities of the Cities of Chesterfield and Creve Coeur have determined, in the spirit and intent of the legislation creating the Boundary Commission, that the annexation of the unincorporated territories lying between them should occur in systematic stages commencing at the earliest time permitted by law and finishing not later than January 1, 1996:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, MISSOURI AS FOLLOWS:


Section 1: The City Council, after due consideration, has determined to enter into an agreement with the City of Creve Coeur, Missouri, providing for the establishment of future boundary lines for their respective jurisdictions within the unincorporated territories of St. Louis County lying between said municipalities as set forth in the attached map, marked Exhibit "A" and made a part hereof.

Section 2: The said corporate authorities agree to limit any future annexation of unincorporated territory set out on Exhibit "A" to said lines.

Section 3: The City Council hereby petitions the St. Louis Boundary Commission to approve the proposed boundary lines set forth in this agreement and to authorize the submission of these changes to the voters of the respective municipalities and the unincorporated areas affected in accordance with the attached schedule.

Section 4: The Acting Mayor is hereby authorized and directed to execute on behalf of the City this agreement with the City of Creve Coeur, Missouri, and to take such other actions as he deems necessary to effectuate the terms of this agreement.

SECTION 2: THE PARTIES AGREE TO LIMIT ANY FUTURE ANNEXATION OF UNINCORPORATED TERRITORY BETWEEN THEM AS SET OUT ON EXHIBIT "A" TO SAID LINE.

SECTION 3: THE PARTIES AGREE THAT THE SCHEDULE FOR SUBMISSION OF PROPOSALS TO ANNEX SPECIFIC UNINCORPORATED TERRITORIES BY ANY PARTY TO THE ST. LOUIS COUNTY BOUNDARY COMMISSION WITHIN THE BOUNDARY LIENS ESTABLISHED IN EXHIBIT "A" SHALL BE DETERMINED SOLELY BY THE GOVERNING AUTHORITY OF THAT PARTY.






