

RESOLUTION #95

WHEREAS, the City of Chesterfield has made efforts to recognize its responsibilities to the citizens of Chesterfield in case of city-wide or area-wide emergencies; and

WHEREAS, part of the responsibilities of the City will be to provide facilities, goods and services to the citizens who are victims of disaster; and

WHEREAS, the facilities and services may include buildings, grounds and equipment, service activities and other similar related and required needs; and


WHEREAS, the City has established a plan to provide assistance to its citizens and along those lines feels that it is in the best interest for the health, safety and welfare of the citizens to make arrangements in advance with certain individuals, owners, operators and entities for the use of their facilities.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

1. The City Administrator, with the concurrence of the Director of the Department of Planning and Economic Development, is empowered to enter into an agreement whereby the City of Chesterfield will obtain the consent for the use of facilities as mass care shelters in cases of a natural disaster, city-wide emergency, area-wide emergency or when authorized by the Mayor and City Council of the City of Chesterfield.

2. Said agreement shall be in the form substantially consistent with Exhibit "1" which is attached hereto and made a part hereof as if fully set out herein.

3. This Resolution will be in full force and effect from and after its passage and approval.

STATEMENT OF AGREEMENT
CONCERNING THE USE OF FACILITIES AS MASS CARE SHELTERS
BY THE CITY OF CHESTERFIELD

This agreement is made and entered into between the governing board of LORD OF LIFE LUTHERAN CHURCH, Chesterfield, Missouri, and the City of Chesterfield.

RECITALS

Pursuant to the Emergency Preparedness Policy, the City of Chesterfield may be required to provide emergency services in behalf of individuals and families who are victims of disaster. LORD OF LIFE LUTHERAN CHURCH is authorized to permit the City of Chesterfield to use ITS buildings, grounds and equipment for mass care shelters and/or provide services as required in the conduct of City of Chesterfield Disaster Services activities, and wishes to cooperate with the City of Chesterfield for such purposes.

The parties hereto mutually desire to reach an understanding that will result in making the aforesaid facilities of LORD OF LIFE LUTHERAN CHURCH available to the City of Chesterfield for the aforesaid use. NOW, THEREFORE, it is mutually agreed between the parties as follows:

1. LORD OF LIFE LUTHERAN CHURCH agrees that, after meeting its own responsibilities to its pupils/parishioners/members/clients, it will permit, to the extent of its ability and upon request by the City of Chesterfield, the use of its physical facilities, equipment and services, by the City of Chesterfield as mass shelters for the victims of disasters.
2. The City of Chesterfield agrees that it shall exercise reasonable care in the conduct of its activities in such facilities and further agrees to replace or reimburse LORD OF LIFE LUTHERAN CHURCH for any foods or supplies that may be used by the City of Chesterfield in the conduct of its relief activities in said mass shelters.

IN WITNESS THEREOF, the governing board of the LORD OF LIFE LUTHERAN CHURCH has caused this agreement to be executed by the President of its governing board, and the City of Chesterfield has caused this agreement to be executed, said agreement to become effective and operative upon the fixing of the last signature hereto.
