AMENDMENT OF ARTICLES OF INCORPORATION
OF
THE INDUSTRIAL DEVELOPMENT AUTHORITY OF THE
CITY OF CHESTERFIELD, MISSOURI

Pursuant to the provisions of Chapter 349 of the Revised Statutes of the State of Missouri ("Industrial Development Authority Act"), the undersigned persons constituting the Board of Directors of The Industrial Development Authority of the City of Chesterfield, Missouri certify the following:

SECTION 1

The present name of the Corporation is The Industrial Development Authority of the City of Chesterfield, Missouri, which is the name under which it was originally organized.

SECTION 2

An amendment to the Corporation's Articles of Incorporation was adopted by unanimous consent of the Board of Directors on August 6, 1997.

SECTION 3

Article 7 of the Articles of Incorporation is amended to read as follows:

Except as may be otherwise specifically provided by statute, or the articles of incorporation or the bylaws of the corporation as from time to time amended, all powers of management, direction, and control of the corporation shall be, and hereby are, vested in the board of directors. The board of directors of the corporation shall consist of twelve (12) directors, all of whom shall be qualified electors of and taxpayers in the City of Chesterfield, Missouri. Thereafter, the number of Directors shall be fixed by, or in the manner provided in, the bylaws, but

shall not be less than three (3). Any change in the authorized number of Directors shall be reported to the Secretary of State of Missouri within 30 days after such change. The directors shall be appointed by the Mayor with the advise and consent of a majority of the City Council of the City of Chesterfield, Missouri, and they shall be elected so that they shall hold office for staggered terms.
