

**A RESOLUTION AUTHORIZING THE CITY OF CHESTERFIELD TO APPLY FOR A MUNICIPAL PARKS GRANT FOR CHESTERFIELD VALLEY ATHLETIC COMPLEX PLAYGROUND DEVELOPMENT PROJECT.**

WHEREAS, the City is an expanding municipality in the growing County of St. Louis, and

WHEREAS, the City Council deems it necessary to improve its public parks to serve its citizens as well as the traveling public; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THIS CITY OF CHESTERFIELD, MISSOURI AS FOLLOWS:

Application be made under the Municipal Parks Grant of the County of St. Louis for a grant-in-aid for the partial cost of the project, reimbursable upon completion by the Commission.

That a project proposal be prepared and submitted to the Municipal Parks Grant Commission.

The City Council hereby authorizes the City Administrator to sign and execute the necessary documents for forwarding the project proposal application for a grant-in-aid under the Municipal Parks Grant Commission.


If a grant is awarded, the City of Chesterfield will enter into an agreement or contract with the Commission regarding said grant.

As you are aware, Staff has submitted a grant proposal to the County Municipal Parks Commission for the addition of rubberized playground surfacing and shade structure to the Chesterfield Valley Athletic Complex West Playground in the amount of \$177,841.25.
